SOURCE MEDIA REQUIREMENTS

1. All Blu-Ray images must be authored to accept AACS encryption. Technicolor can accept both pre-encrypted and unencrypted AACS images. Unencrypted AACS images will be submitted to AACS for certification. In this case please provide your AACS license number.
2. Wam!Net source delivery is acceptable. This method requires an established Wam!Net connection and trading relationship with Technicolor. The package must be identified using the Technicolor GIL naming convention. Contact your assigned Technicolor Customer Service Representative for GIL naming requirements.
3. If physical media is provided, Technicolor accepts LTO which is preferred source or a USB 2.0/Firewire compatible hard disk. The image supplied on LTO must be archived using Windows Backup format. Contact your assigned Customer Service Representative for format requirements on images supplied via hard disk.
